 MINUTES OF THE LAST MEETING HELD ON 4th DECEMBER 2018 were read and with the addition of Rosemary Hewitt to the list of Apologies for Absence were approved and signed as a correct record of the meeting.

4. MATTERS ARISING FROM THE MINUTES

Item 3. APPROVAL OF THE MINUTES OF THE LAST MEETING - RH queried why the amendment was made and also why the date, 28th November, was omitted.

Item 7 b) RH asked where *the tree with the crack in it* was located? DH replied that it was towards the top of Cryers Hill Road.

5. TREASURER'S REPORT

The Summary of Receipts and Payments covered the last two months because our last meeting was in December. A grant of £500 had been received from the Parish Council, slightly lower than the £520 the previous year, but it came with a caveat that the magazine, *Hughenden News*, should be distributed to everyone in the Valley. As residents pay a HVRA membership fee of £5, this issue was discussed under Item 7 d) iii below.

PC had received a few more subs, and the 5 people that had paid twice will have their subs carried forward to next year. The HVRA have contributed £600 towards the Notice Board that is located at the end of the village shop and paid the costs for the website domain. We had a deficit of £157 for the months of December and January which has been brought forward.

There are two Deposit Accounts: HSB**C** Money Market A/C with a fixed rate for 3 months holds £5,009 and £1,065 is in another Deposit A/C that has ease of access, and £1,500 is held in the Current A/C. Subs have been received from 434 households with a further 20 from Valley Road. Subs still due from South Maundin, Bryants Bottom (JP), Trees Road, Warrendene Road, Hampden Road and part of Cryers Hill Road. GT responded that, bearing in mind some other issues going on in Trees Road, he had collected as many subs as possible.

PC had drafted a letter to several residents that "are not community minded" setting out the benefits of being a HVRA member and living in a pleasant community that the Residents Association works hard to create. After a brief discussion **it was agreed** that, with several modifications, PC sends his letter to two residents in Friars Gardens.

As JD is stepping down from producing the magazine, Jill Graham has asked JD what is involved and if she is agreeable PC would appreciate her help contacting advertisers while he deals with the financial side of advertisements.

7. HVRA COMMITTEE BUSINESS

- a) Road Reps Reports and Emails
- i) Bryants Bottom JH reported that 7 residents went to Aylesbury to meet David Lidington MP about the atrocious state of the top end of Bryants Bottom Road where signage states it has a "failed surface". He was completely aware of the road and its poor condition, and would approach Wycombe District Council to see what their plans are. The residents complained that despite paying a huge Council Tax bill they have no street lights, no pavements and a road that is not fit for purpose. If nothing is done about the road, then they want the road closed. Residents are awaiting a progress report.

JH was asked to write a piece for the magazine and the website.

During the recent snowy conditions JH drove at 30 mph along her road but an irresponsible motorist overtook her at speed.

ii) Cryers Hill Road Parking Bay – Month after month a low-loader and a van have been parked on the layby despite residents reporting them to the DVLA and WDC because one was registered as "SORN" (vehicle off the road) and the other was not taxed. But a week last Sunday the DVLA clamped them and now the vehicles have gone!! DH had written to Cllr David Carroll asking whose responsibility it is when vehicles park up for months, but to date she has not received a response. Numerous residents had written letters of complaint to put pressure on TfB to do something but it was the DVLA that finally acted.

Update: Cllr David Carroll has had the vehicles removed from the bus layby opposite

DH appreciated seeing so many pretty snowdrops along the grass verge near the surgery. All had planted them some time ago.

Coombe Lane - Al expressed his concern that once again Coombe Lane had become treacherous and unsafe in the recent snowy conditions. JI reported that a bus could not continue its journey down Coombe Lane because it was snow-clad but with the help of several local residents the driver was able to reverse into Hunts Hill Lane and then travel back along Main Road, Naphill and via Bradenham to High Wycombe.

Al believes a cost/benefit analysis of comparing the cost of obtaining and maintaining permanent emergency signage to warn drivers of the dangers of this this very steep hill (16%) during dangerous conditions, compared with the costs involved every time there are incidents during snow/ice conditions, from the use of services such as The Police, Emergency Recovery Service and the cost of repairing vehicles and the insurance involved, it would be highly beneficial to the County Council's budget. He will continue to pursue this serious matter through the good offices of Hughenden Parish Council

- **iv)** Trees Road GT stressed that people should be vigilant because a local Facebook Group had warned that several large men were knocking on doors selling "rubbish" items. JM warned that they were frequently known as the "Nottingham Knockers" and that we should not engage with them because they could be "sizing-up" the area.
 - All has a small supply of "No Cold Calling" notices but could acquire more if necessary. The police have excellent crime prevention leaflets.
- **Valley Road** RH enquired whether cars "For Sale" were still being parked on the grass verge outside Chiltern Motors. She had previously submitted an on-line complaint because it is against Green Belt and AONB Policy. Although members had not seen any, she will keep an eye on the situation.

7 b) Planning

Ref: 18/0764442/FUL Bramble Cottage in Bryants Bottom has been **refused** because the application greatly exceeded the 50% rule as set out in Green Belt Policy GB2.

Ref: 18/07489/FUL Trystene, Valley Road has been **withdrawn**. Several neighbours had submitted objections to the proposed extensions and the double garage being sited along the front garden boundary.

Ref: 18/07330/FUL Lynwood, Valley Road has been **permitted** despite objections from numerous nearby residents that it was overbearing and not in keeping with the neighbouring semis.

WDC's new housing supply has increased so that the 5 year prediction now stretches to at least 8½ years.

ii) Site for HPC Notice Board

JI has replied to a letter from the Deputy Clerk about where to locate the HPC Notice Board. She explained that the existing one, located outside the former village shop and close to the telephone box, is old and the glass mists-up. It stands in an awkward elevated position above a raised wall/plinth making access for placing notices inside very difficult indeed. It should be replaced because the location is convenient for the majority of residents who walk and motorists too, who can park in the layby, to use the letterbox.

iii) HPC Grant Feedback

JI had received a letter from the Clerk regarding the £500 grant it has given to the HVRA and the caveat that the magazine is distributed to every household. (It is understood that two Councillors proposed this). JI replied that the magazine is distributed to all members who pay the £5 annual HVRA membership fee, not just in Hughenden Valley but also in Bryants Bottom, Hampden Road, Cryers Hill Road and Church Farm. The Committee discussed this issue at length and it was noted that some residents do not wish, for a variety of reasons, to be members nor do they wish to receive the magazine. Please email the Co-Chairs with any further questions or comments.

d) Bryants Bottom News Update

JH reported the incident that occurred early on Saturday morning, 2nd February, when a white Ford Connect van careered down Bryants Bottom Road, and at 3.54am crashed into a vehicle. Then at 3.57am deliberately drove into JH's wooden garden gates, smashing one and damaging the other. The van went on to hit three other vehicles further down the road and when it arrived at The Gate the driver smashed the windscreen of the Manager's car with a wheel brace. JH has since learned that some damage had been done to several vehicles in Warrendene Road, e.g. wing mirrors etc. The Police were notified and a crime reference number given. A little piece of plastic that covered the van's tow is now held. All the residents that were affected have reported this reckless incident to the Police for further investigation.

9. OTHER REPORTS

Village Hall a)

The Village Hall's AGM took place at the beginning of January, and their February meeting was held last night when Officers were nominated. Michael Sole remains as Chairman. Clive Webb replaces Dillon Jones as Secretary and Jonathan Hilder takes over from Bob Hawkins as Treasurer. Roger Bryan is the Assistant Treasurer. Christine Powell remains as Booking Secretary which she has ably carried out for the past 35 years. The proposed HPC Notice Board was discussed at their meeting, but as the Village Hall had contributed to the Notice Board located on the village shop it was felt that the Parish Council could share some of the space. In response, HVRA Committee members commented that there could be insufficient space to accommodate news/events from the Shop, the HVRA as well as residents' posts/adverts etc. (More discussion of this issue appears at item 7 d) ii above.)

The Winter Walk at the beginning of the year attracted about 35 people who greatly enjoyed the experience and MS encouraged everyone to join them on their next walk. He praised the conservation team for their hard work throughout the year.
